The Task Force Releases a Value-Based Cardiology Case Study Featuring Chamber

WASHINGTON (February 26, 2026) – The Health Care Transformation Task Force (Task Force) – a group of leading health care payers, providers, purchasers, patient organizations, and value transformation partners – released a new case study in collaboration with Chamber. The publication, *Driving Value-Based Cardiology Care at Scale*, highlights Chamber’s care strategy, financial arrangements, and outcomes. This publication coincides with [American Heart Month](#), recognizing the importance of advancing high-quality, prevention-focused cardiovascular care.

Chamber’s model provides cardiologists with real-time data, shared workflows, and flexible financial arrangements – including capitation – across Medicare Advantage and other risk-bearing entities. Chamber has shown meaningful reductions in inpatient admissions, emergency room utilization, and total cost of care, demonstrating the impact of shifting care upstream in one of the highest-cost areas of medicine.

“Heart disease is one of the most significant drivers of health care spending, yet cardiology has often been left out of value-based payment models,” said Theresa Dreyer, CEO of the Task Force. “This case study shows how empowering specialists with the right infrastructure and aligned incentives can meaningfully improve outcomes while reducing avoidable costs.”

“Cardiologists are uniquely positioned to prevent hospitalizations and slow disease progression when they have timely data and support,” said George Aloth, Co-Founder and CEO of Chamber. “Our model is designed to make high-quality, guideline-driven cardiology care sustainable and scalable, while rewarding physicians for delivering better outcomes for patients.”
